### Preparedness to contributing towards the SDGs

To contribute to the SDGs through localisation and integration of the SDGs across the state of Nagaland, the Government of Nagaland has established the SDGCC under the Planning & Coordination Department in partnership with UNDP.

**Developments so far:** With dedicated human resources engaged for furthering the mission, the status of implementation of SDGs through SDGCC so far are as follows:

- Capacity building workshop and consultations held at the state level for taking forward the SDGs.
- Departmental SDG Cells in all relevant departments created with Nodal officers.
- High Level Steering Committee constituted, headed by Chief Secretary.

- Mapped all flagship schemes, state schemes and projects to the SDGs.
- Finalized the State Indicator Framework (SIF) and District Indicator Framework (DIF) aligned to National Indicator Framework to track and monitor the progress of SDGs at state level.
- Established database of all SIF indicators with baseline, source and short, medium and long term targets.
- Drafted SDG 2030 Vision Plan for Nagaland (To be released).
- Drafted District Manual for SDG localisation and integration (To be released).
- Published SDG brochure for localisation: 'Building Stewardship on Agenda 2030 in North East India'.

#### Status of Nagaland as per NITI Aayog SDG Index 2.0

**Recognition**: The SDG India Index 2.0 has recognised the positive contribution of Nagaland as follows:

- Overall score: Nagaland has achieved a score of 57 as compared to the average national score of 60.
- Top performing State for Goal 12: Sustainable Consumption and Production.
- Front-runner for Goal 2: Zero Hunger with a score of 70% above the national average of 35%.
- With regards to percentage of anaemia among children aged 6 59 months, Nagaland has already crossed the national target of reducing anaemia among children to 14% until 2030 by achieving 8%.
- The lowest rate of crime among women is Nagaland with a record at about 7%.
- Front-runner for Goal 6: Clean Water and Sanitation with a score of 75%, Goal 7: Affordable and Clean Energy with a score of 70%, Goal 15: Life on Land with a score of 94% and Goal 16: Peace, Justice and Strong Institutions with a score of 84%.
- Of the 239 wildlife crime cases reported in India between 2017 and 2018, Nagaland registered only one such case.
- Nagaland has not reported any incident of human trafficking.

- Use of Drone-assisted messaging on do's and don'ts for COVID-19.
- The Nagaland COVID-19 self-declaration application for tracking high risk COVID-19 cases was launched.

# In the Spotlight: SDG 15 Amur Falcon Conservation: Achieving 'Zero Hunting'

In every Newsletter, we bring to you an 'In the spotlight' section which covers one initiative that is being implemented that contributes primarily to one SDG. In this issue, we are covering the Amur Falcon Conservation efforts being undertaken by the Department of Environment, Forest & Climate Change, Government of Nagaland that contributes primarily to SDG 15 – Life on Land.

**Background**: The Amur Falcon is a species from the Siberian region which migrates to the African region for wintering covering a long distance of 22,000 km and completing an elliptical loop. While migrating, it stops at several places in Northeast India with the main roosting site being Doyang catchment area in Nagaland before taking off again. In 2012, NGO 'Conservation India' came out with a report of mass killing of the birds in the Doyang catchment area, mostly in Pangti village which triggered conservation efforts being undertaken which have continued ever since.

**Intervention**: The Department has undertaken the following actions:

- Deployment of frontline staff at roosting sites to control the killing, trapping and selling of the birds.
- A Sub-committee consisting of all the territorial Divisional Forest Officers and Wildlife Warden was constituted to supervise at the field level.
- Awareness programmes on Amur Falcon Conservation.

- Distribution of IEC to generate widespread public awareness about Amur Falcon.
- Constituted District Level Co-ordination Committee for controlling wildlife crime.
- Notified policy of zero tolerance to the hunting, killing and trapping of Amur Falcons in the State.

#### **Outcomes and achievements:**

- **Conservation Action Plan of Amur Falcon** which includes involvement in protection work, eco-tourism, habitat improvement and research.
- **Enhanced awareness** on conservation issues among general public.
- Full protection of Amur Falcon which has also been extended for other species too.
- · 'Zero Hunting' zone and named as the' Amur Falcon Capital of the World' by UNEP.
